This statement confirms that the Victrex grades listed above have been tested to the flammability testing standard UL94¹ and meet the requirements of UL94-V0 at 3.0 mm thickness, demonstrated by type testing of representative samples. Further information, including information on the thicknesses tested, can be obtained from the UL product database available at https://productiq.ulprospector.com/en under document name QMFZ2.E161131.

The above Victrex grades have <u>not</u> been tested against the requirements of the FMVSS 302² flammability standard specific to the automotive industry since the UL94 testing standard is considered as one of the most widely recognised and stringent flammability testing regimes that may be applied across multiple intended application areas. The table below compares the test conditions for FMVSS 302 and UL94-V0 to help towards understanding the similarities and differences between the two tests.
